1 The Court, the Honorable Charles W. McCoy presiding, previously entered
2 the following orders in this action: (1) Order dated April 1, 2003 granting Defendant
3 DIRECTV, Inc.'s Special Motion to Strike Plaintiffs' Complaint Pursuant to Cal. Code
4 Civ. Proc. § 425.16 and dismissing this action with prejudice; (2) Order dated May 23,
5 2003 denying Plaintiffs' Motion for Reconsideration of the Order Granting DIRECTV,
6 Inc.'s Special Motion to Strike; and (3) Order dated June 9, 2003 granting Defendant
7 DIRECTV, Inc.'s Motion to Determine Amount of Attorney's Fees and Costs
8 Recoverable Pursuant to Cal. Code Civ. Proc. § 425.16 and awarding to DIRECTV, Inc.,
9 and against plaintiffs, the sum of \$97,222.10 in attorney's fees.

10 NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED
11 that judgment be entered against plaintiffs Kevin Blanchard, William Cooper, John
12 Lund, Michael Spencer, Rod Sosa, Gary Whittaker and Rodney Bylsma, each of whom
13 shall recover nothing, and in favor of defendant DIRECTV, Inc. on all causes of action.

14 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
15 defendant DIRECTV, Inc. shall recover from plaintiffs the sum of \$97,222.10 in
16 attorney's fees, pursuant to Cal. Code Civ. Proc. § 425.16(c), and that plaintiffs Kevin
17 Blanchard, William Cooper, John Lund, Michael Spencer, Rod Sosa, Gary Whittaker and
18 Rodney Bylsma shall be jointly and severally liable for the payment of such attorney's
19 fees to DIRECTV, Inc.

20 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
21 DIRECTV, Inc., as the prevailing party in this action, shall have and recover from


